In consideration of the 2018 Holiday Bazaar Vendor Application, I, the undersigned ("Vendor") am authorized to sign for Vendor and assume full and complete responsibility for any injury or accident which may occur during my participation in the 2018 Burleson Area Chamber of Commerce Power of Heels Holiday Bazaar, including but not limited to the time that I or any individuals or parties acting on my behalf are on the premises of the event. I hereby release and hold harmless the sponsors, promoters and all other persons and entities associated with this event (collectively known as BACC POH Holiday Bazaar) I additionally assume full liability and responsibility for any property damages caused by in part or entirety by my sole participation or by the participation of any employees or individuals acting on my behalf at or in conjunction with this event. I further agree and understand that I, as a Vendor and participant, release BACC POH Holiday Bazaar from any and all responsibility of liability of any kind for any loss, injury or damage of any kind to the Vendor or Vendor's property of merchandise. All expenses of transporting, packing, unpacking and insuring Vendor's property or merchandise shall be the sole responsibility of the Vendor. BACC POH Holiday Bazaar may cancel the Bazaar and/or Vendor's area at any time at its sole option. The only liability which BACC POH Holiday Bazaar has to the Vendor in the event of such cancellation shall be the refund of all fees paid by the Vendor, which we receive by BACC POH Holiday Bazaar prior to such cancellation. BACC POH Holiday Bazaar shall not be responsible for the loss of goods, merchandise, displays, or other materials resulting from fire, flood, theft, vandalism, acts of nature or any other cause. Vendors are hereby advised that BACC POH Holiday Bazaar will not carry insurance to cover damage or loss sustained by Vendors, their personnel, and/or guest. All fees are due at time of submission of the Vendor Application. Vendors are responsible for providing their own tables, chairs, displays or other items needed for the efficient operation of their booth. Nothing may be affixed to the floor, walls ceiling, or any of the premises of the Holiday Bazaar location.

All proceeds of a Vendor's sales shall be retained by the Vendor, and each Vendor is responsible for the collection and remittance of all taxes relating to its sales and for indemnification of an holding BACC POH Holiday Bazaar harmless from any failure by the Vendor to collect and remit such taxes in accordance with applicable law.
